

Dear Resurrection People,

"You must understand this, my beloved: let everyone be quick to listen, slow to speak, slow to anger." -James 1:19

While there are quite a lot of ways that being a Christian runs counter to the culture around us, I think there may be none quite so striking as this instruction from James. Then, as now, sin tells us not to listen to others, but rather to jump to conclusions about what they are thinking or doing based on just a few interactions. Sin tells us to be louder than anybody else, quicker to sarcasm or biting one-liners than to sincere listening.

James tells us that if we are to live as beloved siblings in God's family, we must reject the urge to say whatever comes to mind and replace it with the commitment to listen. To misquote a famous musical: Talk less. Listen more. This isn't to keep our beliefs hidden away, but because James is wise enough to realize that being quick to listen and slow to speak also keeps us slow to anger. God gave us two ears and one mouth, and that should be a big hint to all of us that we need to listen more than we need to talk.

But who or what are we listening to? Well, our fellow beloved siblings in Christ, for one! The apostle Paul tells us that we do that by "speaking the truth in love." On the surface, it may seem like speaking the truth in love for the sake of building up the body of Christ means that ideally, we will never say anything that will make someone else in the body upset. But you and I both know that this is not always a reality. Often, speaking the truth in love means saying exactly what we mean and exactly how we feel. Speaking the truth in love can only happen when we trust one another. Trust, above all, that the person to whom we're speaking is more quick to listen than to speak; in other words, that we will be listened to just as we commit to listen to others.

As we continue to do ministry together, James reminds us to do the hard work of listening more and speaking only to speak the truth in love with one another. This happens through speaking directly to the person with whom we need to communicate, even when we think what we have to say might make the other person upset. Because in God's family, we are quick to listen and when we speak, we speak the truth in love.

This also prevents the temptation to communicate through anonymous communication. It's impossible to listen, really listen, if communication happens second-hand. "Some people are saying..." means that

Summary of October Council Meeting

Call to Order: by Vice President Jerry Tonneson at 6:29 pm

(Note: Motions are shown in the meeting minutes in bold italics.)

Opening Devotions: postponed until next month

September Meeting Minutes: approved by Council

September Financial Reports: Giving on the year is down \$44,000. Overall, funds are down \$32,000 from the previous year. Included in the numbers are a payout to Grace for 29 days of unused vacation.

The cell tower fund balance is currently \$67,000. Proposal to invest \$50,000 of these funds in short-term CDs at an interest rate of 3%. The building for Christ fund balance is currently \$40,000. Proposal to invest \$40,000 in short-term CDs at an interest rate of 3%.

Bell Tower Requests: Request for a microphone with specific details forthcoming.

Board Highlights:

Social Ministry – E-Team: 40 people attended the Wednesday community meal in September. October meal is scheduled for Wednesday, October 19. Planning is ongoing for November shelter meal. E-Team has a new chair and they are currently working on reviewing Board descriptions.

Youth – Christian Ed: Both Boards met with Grace prior to her departure. Christmas program is scheduled for Sunday, December 4 at 4 pm.

W&M – **Congregational Life:** Attendance for the last two Saturday services was 15 and 10. Going forward, the U.S. flag and the Christian flag will both be displayed in the fellowship area and not the sanctuary. The Ecumenical Thanksgiving dinner will be held on Tuesday, November 22. Advent soup suppers are in the plans with details to come. More plates will be ordered for the soup suppers.

Property – Stewardship &Finance: Property did not

have a meeting this month but is going to start planning a monthly checklist for needs/duties.

OLD BUSINESS

Cottage Meeting Report: About 50 people attended the meetings. Details of meetings with specifics forthcoming.

Decide on Community Meal for November: Council will serve meal. Scheduled date for Wednesday, November 16. Food choices are TBD. Should hear by around November 7 as to whether RLC will receive a grant that would help with and increase advertising of the community meals along with helping defray some of the cost of the food.

NEW BUSINESS:

Youth/Family Minister Position: Discussion of what details need to be in place in order to move forward. Desire to craft a job description specific to the position was discussed along with seeing what comments come out of the cottage meeting reports with regard to the position. Pastor Beth was connected with an individual that may be a candidate. This person is currently obtaining his master's degree in children, youth, and family ministry. Discussion also included what potential hours would be best for the position along with maybe reshuffling some hours to Janice. With Pastors Beth's husband starting a new position with benefits, there is a potential to offer Janice benefits instead, with Pastor Beth and family being covered by her husband's company. Should that occur, a motion was brought to offer Janice benefits through Portico and was approved by council. Decide on November Meeting Time: With Election Day falling on the usual meeting day, next month's meeting is scheduled for Thursday, November 10 at 6:30 pm

Thankoffering Service—November 13

Beginning in the late 19th century, Lutheran women were given small Thankoffering boxes to place in a special location in their homes as a visible reminder of blessings received. Women would add coins to those boxes almost daily as particular blessings were noted. From their use came the idea of an annual church service to celebrate their collection, and so the women of the congregation would come together for a Thankoffering service.

In the Lutheran tradition, the General Synod's Women's Home and Foreign Missionary Society created their first Thankoffering service in 1889 to celebrate

the 10th anniversary of the organization. At that first Thankoffering, \$6,100 was collected. Today, Women of the ELCA collects more than \$1 million in Thankofferings annually for the ministries and mission of our women's organization.

RLC will have an opportunity to celebrate the Thankoffering tradition in worship on November 13. Any special offerings made will support the WELCA in creating Bible studies, worship materials, small group resources, and other publications available free of charge to individuals and congregations.

Wednesday, November 16 & Thursday, November 17 Seminars on How Community Land Trusts (CLTs) Create Permanent Affordable Housing. This is something exciting for AMOS church members/ institutions. On these days, AMOS and the city of Des Moines will bring Grounded Solutions, the experts in Community Land Trusts (CLT's), to Des Moines for a series of meetings to inform attendees of the benefits of CLTs.

CLT'S are a way to create affordable housing that stays affordable forever and looks like other properties in the neighborhood so it's welcomed by the neighbors!

How is this possible? With the purchase of a CLT home, the buyer purchases only the structure on the property and a trust holds the land. If the owner later wishes to sell, the owner agrees to accept only a portion of the increase in value in order to preserve affordability for the next buyer. The owner may also choose to pass the property along to his or her heirs.

While this is a new idea for the Des Moines Metro, it is in use in 225 other communities in the U.S. and is

now an integral part of how other communities are dealing with skyrocketing real estate prices. CLTs have a proven track record of:

- offering affordability in perpetuity
- providing for successive lower-income buyers with every property
- preserving the diversity and quality of life in our city
- slowing gentrification
- saving tax dollars for the city and county

Whether you are hearing about CLT's for the first time and want to learn more or are a seasoned advocate for affordable housing, plan to attend one or more of these informative trainings on November 16 and 17. There will be more details soon, but you'll want to get this on your calendar. Feel free to email me should you have questions!
